SIPA's Advocacy Program:

The advocacy program of SIPA was established on the basis of the accumulation of the experiences and lessons learned from the performance of the successive governments of Somaliland, and the practice of the State of Somaliland in relation to the legal regime of Somaliland State formation is observed to have persistent deficiencies in terms of the acquiring knowledge, technical, and administrative skills relevant to the practice of State and the international obligations of the State of Somaliland.

Weaknesses observed include inadequacy of skillful human resources available to actualize statehood, and to administer sovereignty of Somaliland.

The importance of the advocacy program is to mobilize the acquiring knowledge and expertise to address issues of urgency. The national Constitution of Somaliland was ratified through public referendum on 31st May 2001 and enacted, it is almost 23 years from the date of its enactment, and no attention is given legal ambiguities in paragraph 1 of Article 1 and in paragraph 1 & 2 of Article 10 of the Constitution of Somaliland, which constitutes personal opinions that has no legal nexus. These personal opinions constitute "the legal opinion of the Government of Somaliland".

The legal opinion of the Government of Somaliland creates obligation under the rules of customary international law, which is a legal obstacle contrary to the fundamental principles of the Constitution and at the same time opposing Somaliland to manifest sovereignty existing over its territory on 26 June 1960.

SIPA's Open Forum Program:

SIPA's Open Forum Program is designed to offer an open forum platform aiming to promote freedom of expression and exchange of knowledge amongst the intellectuals, elites, academicians and experts with diversity of backgrounds and expertise of specific subject matter.

SIPA's Open Forum Program is an open forum that creates a platform amongst Somaliland citizens in/outside the country to address any decisions and other acts of the international organizations and national key stakeholders in Somaliland which is a decision affecting the people of Somaliland or have impact on the universality of the fundamentals of human rights. The open forum is also addressing other issues of urgency affecting the people of Somaliland whether national, regional or international levels.

Target Groups:

Target groups of SIPA's Open Forum are professionals of different backgrounds such as doctors, professors, lawyers, engineers, economist, agronomist, pharmacist, diplomats, researchers, writers, security and policy analysts/commentators and other experts in the fields of international human rights and humanitarian law, public policy, public international law, international relations and diplomacy in use today's modern world.

Method of the Open Forum:

In order to maximum participation opportunities, SIPA is always trying to use the best practice of the available technology. The method of hosting the Open Forum is online and small round meeting at the

SIPA office for specific subject matter. The reason that, SIPA prefers online is to broaden participation and reach professionals of different backgrounds around the world.

Method of the Open Forum include hosting conferences that aims to inform public policies, human rights, rule of law, good governance and justice. SIPA's conference also objectives contribute and informs concerned stakeholders, at national, regional and international levels.

Schedules of the Open Forum:

The schedule of the Open Forum is governed by the issues to be addressed and its urgency. The schedule of the Open Forum will give consideration time difference of the world, the time of the individual target participant at the time.
